Free Trade Zone

The main distinctive features of the free trade zones of Dubai are:

- 1. The availability of the entire required infrastructure land, premises, roads, connections and etc.
- 2. Clear rights of the foreign business owners.
- 3. Possibility of the 100% foreign participation in the share capital of the company and no need of involving the local citizen as a mandatory participant of the company;
- 4. Full exemption from the corporate and other tax payments and fees;
- 5. Opportunities for the repatriation of the invested capital and gained profits;
- 6. Total absence of the customs duties and fees.



DUBAI – Business in Mainland or in Free Trade Zone

The first thing the Foreign Companies that they need to do when starting their business is to determine whether they want to register a mainland/non free zone company that is able to operate anywhere in Dubai and other emirates, or if they want to register their company in one of the free zones instead.

The **free zones** are the most likely area in which to start a business, as they can offer quite a few advantages for international companies. In fact, the creation of the free zones was meant to be something that would attract foreign companies.

It is crucial to keep in mind that the **mainland company** formation laws require you to have a local partner to have 51% of the equity with a few exceptions like:

- Activities with 100% GCC ownership
- Businesses located in the Free Zones
- GCC company formed in partnership with UAE citizen-instances where GCC companies (wholly owned) enter into a partnership with UAE national
- Where the law requires 100% local ownership
